If the deposit is received prior to the litter being born and a preferred choice is not available (color or gender) the deposit may be transferred to the next litter. The balance is payable in cash at time of puppy pick-up. Veterinary health check, Microchip, 1st vaccination (excluding rabies) and 1st and 2nd worming are included in the price of your puppy.

The following sales contract is made for the mutual benefit and protection of both the buyer and seller. The parties involved in this transaction, buyer, and seller, agree to the following terms and conditions:

- (1) Cowlitz Valley Bernedoodles (seller) is selling this puppy healthy and free of disease and has been vaccinated as appropriate for his/her age. Buyer agrees to keep all vaccinations up to date. All steps possible have been taken to ensure that this dog is structurally, physically, and psychologically sound.
- (2) Buyer must feed appropriate dog food, keep weight in check, and limit exercise in this young puppy. No jumping up and down from beds or couches, no excessive use of stairs, and no forced exercise until the puppy has matured to 12 months of age. Buyer is encouraged to give as much free exercise outdoors as possible.
- (3) Seller represents that to the best of their knowledge, the puppy you have purchased is in good health and is mentally alert. He/she will be examined by a veterinarian prior to its release from Cowlitz Valley Bernedoodles. For the buyer's protection, the seller recommends that you have your own veterinarian examine the puppy within 5 days of purchase. Any dog found not to be in good health at that time may be returned for a full refund or other arrangements may be made as agreed to by the buyer and seller. If the puppy is returned, it must be within 7 days of the exam and be accompanied by the attending veterinarian's report. The exam costs are the responsibility of the buyer.
- (4) Spaying/neutering is required for your dog. Please check with your veterinarian for his/her recommendations of the age spay/neutering should be done.
- (5) WARRANTY: Cowlitz Valley Bernedoodles always uses proven and sound breeding stock. All precautions have been taken for your puppy to grow up to be a sound and healthy adult. It is impossible to "guarantee" that your dog will be free of disorders that pertain to all large breed dogs due to their size (such as OCD -osteochondrosis.) Environmental factors play a large role in the health and development of your dog. It is the buyer's responsibility to provide a puppy food that is formulated for large breed dogs and to be cautious of "over-exercise."
- (6) Cowlitz Valley Bernedoodles offers a 2 year Health Guarantee (from the date of whelping) on the genetic diseases we tested for. The parents of your puppy have been genetically health tested (or their parents have been) and are not carriers or affected by the conditions that can be found in Poodles and Bernese Mountain Dogs.

-**Poodle:** Degenerative Myelopathy, GM2 Gangliosidosis (poodle type), Neonatal Encephalopathy with Seizures, Osteochondrodysplasia, Progressive Retinal Atrophy, Progressive Rod-Cone Degeneration, Von Willebrand Disease 1.

-**Bernese Mountain Dog:** Von Willebrand Disease 1, Degenerative Myelopathy

In the event any of these above occur with your puppy within the first 2 years of life the buyer can return the puppy for a replacement puppy of same sex/color from a future litter. Cowlitz Valley Bernedoodles will require a veterinary report prior to providing a replacement puppy.
